Introduction

The Multi Year Accessibility Plan, as mandated through the Accessibility for Ontarians with Disabilities Act, 2005 (AODA), outlines the University Health Network's strategy to remove barriers for persons with disabilities and to meet its requirements under the AODA. UHN will champion and drive accessibility within the organization to ensure the organization meets or exceeds compliance as legislated by the AODA. UHNs role in the Multi Year Accessibility Plan is to develop, post and implement it's multi-year accessibility plan (MYAP) as an ongoing requirement of the Integrated Accessibility Standards Regulation (IASR,O. Reg 191/11) (IASR) under the Accessibility for Ontarians with Disabilities Act, 2005 (AODA).

AODA aims to ensure greater accessibility for Ontarians of all abilities. The AODA provides guidelines to become barrier-free and includes accessibility standards in:

- customer service
- information and communications
- employment
- transportation
- design of public spaces



University Health Network History

The UHN has grown out of a series of mergers between our current hospitals in and around the Greater Toronto Area. The history of UHN includes:

- 1986 Toronto Western Hospital merged with the Toronto General Hospital becoming the Toronto Western Division and the Toronto General Division of the Toronto Hospital.
- 1998 Toronto Hospital was amalgamated with the Ontario Cancer Institute/Princess Margaret Hospital.
- April 1999 the name was officially changed to the University Health Network.
- July 2011 UHN integrated with the Toronto Rehabilitation Institute.
- February 2014 Altum Health, a division of the University Health Network moved to Krembil Discovery Tower.
- January 2016 UHN integrated with the Michener Institute, now called the Michener Institute of Education at UHN providing opportunities for students in a variety of health professions who will be the future of healthcare in this province.
- April 1, 2024, UHN integrated with Westpark, creating Canada's most comprehensive and specialized rehabilitation and complex continuing care Centre. During this integration, UHN opened the Reactivation Care Centre which provides a supportive space for specialized care, focused on reactivation, for patients who no longer need acute care and are focused on the goal of safely returning to the community.

Anything that prevents a person with a disability from fully participating in all aspects of society because of his or her disability".

Disability:

- 1. Any degree of physical disability, infirmity, malformation or disfigurement that is caused by bodily injury, birth defect or illness and, without limiting the generality of the foregoing, includes diabetes mellitus, epilepsy, a brain injury, any degree of paralysis, amputation, lack of physical co-ordination, blindness or visual impediment, deafness or hearing impediment, muteness or speech impediment, or physical reliance on a guide dog or other animal or on a wheelchair or other remedial appliance or device,
- 2. A condition of mental impairment or a developmental disability,
- 3. A learning disability, or a dysfunction in one or more of the processes involved in understanding or using symbols or spoken language,
- 4. A mental disorder, or



5. An injury or disability for which benefits were claimed or received under the insurance plan established under the Workplace Safety and Insurance Act, 1997.

Aim and Objectives of UHN's Accessibility Plan

- Support UHN to meet the requirements of the Accessibility for Ontarians with Disabilities Act (AODA 2005) in continued compliance with the Customer Service and Integrated Accessibility Regulated Standards (Employment, Information and Communication and Transportation).
- Identify how UHN will remove barriers for Persons with Disabilities who access services, provide service, work, learn, and volunteer at UHN.
- Align with UHN's primary value, "the needs of patients come first" This is aligned with the UHN Patient Declaration of Values:

- Integrate the principles of inclusion, diversity, equity and antiracism with accessibility planning to ensure that the identities, realities and needs of Persons with Disabilities, are included and supported in a manner that is person- centered, respectful, supports the dignity and independence of the individual.
- Ensure that education, training, policies, procedures and practices promote inclusion and learning to eliminate physical, informational, technological, and attitudinal barriers.



Accessibility Project Completions from 2019-2024

2019 Project Completions

The FM-PRO Accessibility Committee developed and rolled out a tracking tool to monitor projects with accessibility components. Training sessions were also conducted to help project managers understand reporting requirements and UHN's responsibilities when it comes to accessibility compliance.

2020 Project Completions

In 2020 UHN made significant progress in accessibility through several projects. The UHN Vinyl Wayfinding project standardized wayfinding related signage for cognitive and visual impairments, improving navigation for patients and visitors. The PMST OPG 6+7 Fit-out improved accessibility for employees and patients by renewing floors 6 and 7 with improved accessibility fit-outs in accordance with the standards for accessibility. The PMB Medical Imaging Signage project ensured that signage is clear, consistent and accessible to improve the imaging experience.

The PMH + TGH Techna Signage project enhanced the directional signage system to align with AODA standards across the research and imaging corridors. TW Power Operators to parking garage were installed. Ramp was constructed at the PM University entrance. Interior and exterior renovations at TR-BC completed – this included a new accessible washroom on floors 2, 3, 4, 5; grab bars on elevators, braille (signage), and slip resistant flooring on the inpatient units.

TR-LC Patient Amenities project was completed - The project was executed as per plan with AODA components such as accessible washrooms and showers, slip resistant flooring. TR-RC Bathroom refresh to ensure user privacy when door opens and to update amenities.



2021 Project Completions

In 2021, the implementation of major accessibility updates included the installation of TWH KDT Washroom Ceiling Lift and a Support bar which increased safety and mobility support during dialysis. The Genesis CT installation was the introduction of a modern scanner room that was accommodation of stretchers and wheelchairs. The room was designed with an accessibly appropriate room arrangement. The PMCC TWH Cardiac Upgrades brought AODA-compliant washrooms with adult change tables into cardiac care environments. With the relocation of SPECT CT, the diagnostic imaging was transferred to a fully accessible area which used tactile and visual cues. The MRI scanner replacement replaced the old equipment with optimized room access and wheelchair accessibility. UHN developed Design & Construction guidelines including accessibility components and requirements that can be applied to all projects.

Paving replacement and new Accessible parking spaces at TR-LC/RC.

TR-BC Elevator modernization. TR-UC Total Modernization of Elevators 1-6 including cab interiors (AODA), controllers, machines and other sub systems supporting the Elevators. TGH ED RAC Expansion to support increase in patient volumes in existing Emergency Department – this project included the installation of a ceiling lift, compliance with washrooms accessories, ADOs, aisle widths, and seating accommodating bariatric & wheelchairs.

2022 Project Completions

UHN's projects in 2022 provided additional accessible outpatient and research access. The TRI LC – Convert Patient Dining Room to Outpatient Therapy Clinic project converted the original space from a dining area into an accessible therapy clinic and created a barrier-free clinic. The TRI Outpatient Clinics Modifications project was to have automatic doors and changed waiting areas from informal layouts to meet the AODA standards for spacing. ORL - Organ Regeneration Labs provides accessible, ergonomic research areas. The TGH Conversion of Observatory Space to Gym



Project provided an area for rehabilitation with a barrier-free space and equipment layout. The Elizabeth Garage Security Enhancements project provided enhancements for parking in areas for emergency calls, better lighting, and accessible wayfinding.

Hillcrest renovations to existing infrastructure and to various life safety systems for code compliance. New standard developed for All Gender Washrooms at PM. Appropriate access control devices were installed in the Michener Simulation Centre. Main floor maps showing accessible washrooms were prepared for TW, TG and PM – this would help direct patients and visitors accordingly. Accessible spaces added to the counter of Real Fruit at PM.

2023 Project Completions

In 2023, UHN was able to improve the surroundings for patients and staff through the following: PM Mammography Equipment Replacement which replaced older imaging equipment with tomosynthesis machines which now have accessibility. TGH 13 & 14ES Nursing Stations and TGH 9 ES Nurse Station Renovations improved entrances points, highlighted barrier free layout direction and staff workflows utilized inclusive design.

FM-PRO Space Implementation provides space for clinical and administrative activities through AODA standards. The Ministry of Seniors & Accessibility conducted an audit of exterior spaces at PM and reported full compliance with standards.

2024 Project Completions

UHN's 2024 completions are all considered based on comfort, safety, and inclusivity.

The completions of 2024 (and associated projects and facilities) were the TRI LC - Patient Lounge Renovation which included expanded pathways and AODA-compliant seating;

The PM Grab Bar Installation project which added hospital grab bars to patient and public washrooms in support of



safety features.

The Patient Furniture for TGH Entrances added accessible and ergonomic furnishings to waiting areas and overall circulation navigation while accessible. MSICU Flooring Repairs ensured all flooring was replaced with anti-slip, low resistance materials for better access. Finally, the TGH Change Room Refresh offered enhanced change rooms with non-slip flooring, wider access (accessible), AODA-compliant lockers, fixtures and access.

Push buttons added to heavily used washrooms near the Leonard Street entrance at TW.

Opening of the Schroeder Pain Assessment and Rehabilitation Research Centre at TR-UC including accessible treatment rooms.

Bell Canada removed 70+ payphones from PM, TW and TG – UHN ensured that at least one payphone with TTY capability was kept in high traffic areas.

Accessibility at UHN

- All persons, including Persons with Disabilities, are able to provide feedback including compliments and complaints based on their experience related to issues of accessibility.



 UHN is committed to ensuring persons with disabilities accompanied by a service animal have the right to access our facilities and services in accordance with the AODA Customer Service Standard. UHN will use its Service Animal Toolkit to support employee training, planning for accommodation, use of standardized signage, documentation, and safe management practices across all sites.

Approach to Engagement

The 2025 to 2029 accessibility multi-year plan approach to engagement includes the perspectives and insights of Patients, Families, Employees, Learners, Physicians, Researchers, Visitors and Volunteers. This approach includes feedback to support UHN's accessibility planning strategy.

a) IDEAA (Inclusion, Diversity, Equity, Accessibility, Antiracism):

An inclusive approach to UHN's accessibility planning ensures that the realities of the lived experience of Persons with Disabilities informs the work of the AAC. The recognition of the diverse identities (i.e. economic status, gender identity, language, literacy and race to name a few) of Patients, Families, Employees, Learners, Physicians, Research, Visitors and Volunteers provides an appropriate cultural context to include diverse perspectives.

Intersectional Approach:

UHN is committed to creating an inclusive environment that values diversity and encourages people to contribute their personal best. IDEAA helps achieve these goals through training, coaching and advice, as well as through the resolution of diversity-related conflict. Participants will learn about IDEAA's services and support, their responsibility as leaders in creating an inclusive work environment, and policies and resources to support inclusion and address disputes and complaints.



IDEAA stands for Inclusion: Fostering belonging, safety and respect in the workplace, Diversity: uplifting, respecting and learning from people with different lived experiences, Equity: positioning community members for success with equal opportunities for growth and development, Accessibility: universal design that welcomes all to learn, contribute and participate, Antiracism: taking deliberate action to identify, challenge, and dismantle racism while protecting and advancing the rights of racialized and Indigenous peoples.

b) Data

The data from departments including Patient Relations, Inclusion, Diversity Accessibility and Anti-racism (IDEAA), FM PRO, Health Services and Safety Services and Security inform the AAC on trends or patterns of existing barriers. This provides opportunities to eliminate future barriers at UHN.

The Accessibility Advisory Council (AAC)

The AAC consists of a broad representation of Employees, Interns, Patient Partners, Leaders and reports to the Director, Inclusion, Diversity, Equity, Accessibility and Antiracism with oversight by the Senior Vice President People and Culture. The AAC represents a range of perspectives and experiences, including those of persons with disabilities and Allies dedicated to promoting accessibility at UHN. The AAC is accountable to guide, advise and make recommendations to advance accessibility at UHN.

The activities of the Accessibility Advisory Committee (AAC) include providing perspectives and input on accessibility-related inquiries received through the accessibility@uhn.ca email, and collaborating with departments such as Patient Experience, Patient Relations, Security, Infection Prevention and Control, Occupational Health and Safety, FM-PRO, and People & Culture. Provincial Health Care Accessibility Standards Development and the Law

The accessibility standards under the act are laws that businesses and organizations with one or more employees in Ontario must follow so they can identify, remove and prevent barriers faced by persons with disabilities. These standards are part of the act's Integrated Accessibility Standards Regulation (IASR). Currently, there are five accessibility standards that apply to key areas of day-to-day life for Ontarians. These are:

- information and communications
- employment
- transportation
- design of public spaces
- customer service

Monitoring

The Accessibility Advisory Committee (AAC) meets monthly to monitor progress of the planning activities related to accessibility deliverables under the AODA and review feedback received from all sources about accessibility at UHN. As the AAC reviews progress on all aspects under the AODA, the members may request additional information if needed, provide recommendations and escalate issues to address any barrier to accessibility.



Communication of the Plan

The UHN multi-year accessibility plan is available on internal and external websites. The plan will be readily available upon request in an accessible format including hard copy and large print. Additional formats may be available based on the individual merit of the request.

We are committed to providing equal treatment and opportunity and strive to ensure that Persons with Disabilities access UHN's goods, facilities, programs and services.
