1. Announcements

2. Minutes

The minutes of January 18, 2018 were reviewed and accepted.

3. Safety issue re: 7th floor bathrooms at Toronto Western

 The Council endorsed the recommendation for the 7th floor staff washroom at Toronto Western Hospital to be converted into an accessible public washroom to accommodate the absence of one currently on the floor.

4. Brainstorm: Entrance/Accessible Washroom Requirement Strategies

- The Council confirmed the following plan of action regarding addressing priority hospital accessibility issues in conjunction with the approved physical audit by Bob Topping, accessibility architect with DesignAble Environments, and the overall goal of creating UHN accessibility standards:
 - Carry out priority physical audit of entrances, accessible washrooms and door operators in most publically accessible areas throughout all major UHN sites.
 - Audit should be carried out in accordance with current AODA and OBC requirements.
 - The goal of the audit will be to determine if targeted areas are accessible in its current state, with review of 2025 guidelines, and to make recommendations for improvement.
 - Priority areas will be informed by Patient Relations complaints and existing project requests.
 - 2. Organizational endorsement for creation of accessibility guidelines for UHN via SBAR.
 - Council to draft SBAR to relevant UHN leaders to communicate need for the allocation of resources for the creation of accessibility guidelines in order to optimize accessibility within the organization.
 - 3. Create accessibility guidelines draft.
 - -Jacquie to send AODA Council examples of other accessibility guidelines.

5. Service Animals Update

- The AODA Service Animal Tracer Work Plan and Logistics documents have been finalized.
- Dates, locations and observers throughout the organization have been identified.
